# **Big Local White City**

Big Local is an exciting opportunity for residents in White City to use a pot of £1m to make a positive and lasting difference to their communities. It encourages the involvement of individuals, groups and organisations who want to make their area an even better place to live.

# **Big Lottery Fund**

The Big Lottery Fund is a funder committed to bringing improvements to communities and the lives of people most in need. They do this by distributing money raised from the National Lottery to good causes throughout the UK and since June 2004 have awarded over £6bn to projects supporting health, education, environment and charitable purposes.

# **Charity Bank**

Charity Bank is a community of like-minded individuals all working towards one goal.

Our borrowers, savers, shareholders and staff are helping to support charities and social enterprises so that they can always be there when people and communities need them.

# Community Accountancy Self Help (CaSH)

CaSH is a community accountancy project that provides financial advice and training to small charities and voluntary groups. Services include one-to-one casework, training courses and publications, which provide people with basic financial skills needed to run successful organisations.

#### **Global Giving**

Global Giving is the first and largest global crowdfunding community that connect charities, donors and companies in nearly every country around the world. We offer capacity building services to our UK network and we work with small to medium sized charities to connect them to the funding, tools and Training that they need to be more effective.

#### **Hammersmith & Fulham Clinical Commissioning Group Engagement**

NHS Hammersmith and Fulham Clinical Commissioning Group (HFCCG) is an organisation made up of 30 GP practices. The CCG is responsible for planning and commissioning health services for people living in the borough of Hammersmith and Fulham. Their aims are to improve patient care, reduce health inequalities, and raise quality and standards in a way which is efficient and financially sustainable.

### Hammersmith & Fulham Volunteer Centre (HFVC)

HFVC promotes supports and develops volunteering across West London. They provide information, advice, guidance and training to get people into employment and education. HFVC also provides professional services such as corporate events and Challenge Days through its social enterprise arm, Works4U.

#### **Hammersmith United Charities**

Offering grants to organisations working to prevent or relieve hardship or distress across Hammersmith. They welcome enquiries from groups of all sizes, and are particularly interested in working with groups with strong links to the communities they serve.

#### **In Kind Direct**

In Kind Direct is one of The Prince's Charities. Its purpose is to **inspire product giving for social good** by redistributing high-quality goods, donated by some of the UK's best known manufacturers and retailers, to charities working in the UK and abroad. Product donations vary but typically clothes, toiletries, cleaning products, toys and more everyday essentials can be found and ordered via our online catalogue. Since 1996, over **8,000 charities** have received products from In Kind Direct, helping them to save money on their operational costs, enabling them to focus their funds on support, not supplies.

# John Lyon's Charity

John Lyon's Charity gives grants to benefit children and young people up to the age of 25 who live in nine boroughs in northwest London. The Charity's mission is to promote the life-chances of children and young people through education. Since 1992, the Charity has distributed over £90million to a wide range of services for young people, including youth clubs, arts projects, counselling initiatives, childcare and parental support schemes, sports programmes and academic bursaries.

# **Kensington & Chelsea Foundation**

The Kensington & Chelsea Foundation is an independent charity linking local residents, businesses and schools to charities based in the Royal Borough. The Foundation raises awareness of local needs and raises money and in kind support for local charities and groups working hard to address them and the inequalities that exist within this diverse community, where some wards rank amongst the country's most deprived. They also create their own impactful, high-profile campaigns to help combat and address specific local issues.

# **Kensington & Chelsea Social Council (KCSC)**

KCSC is a Council for Voluntary Service (CVS) and is the support body for voluntary and community organisations across the Royal Borough. They provide a wide range of organisational development support for locally focused charities and community groups, as well as developing a voice for the sector to influence decision makers.

# **London Borough of Hammersmith & Fulham Community Investment Team**

The Community Investment Team supports the vibrant community & voluntary sector in Hammersmith & Fulham. Community Investment administers the Third Sector Investment Fund and Fast Track Small Grants, assist with premises and provide support to infrastructure organisations in the borough. The Fast Track Small Grants funding scheme offers funding up to £5,000 (in some cases up to £10,000); it is open all year round. Community Investment wants to encourage more grass roots organisations to take advantage of it. The Third Sector Investment Fund is open at regular intervals (between 2 and 4 years) to organisations looking to fund larger projects and services.

### **Local Giving**

The Localgiving London Development Programme aims to help groups to diversify and grow the income they receive, making them more resilient and sustainable.

### **London Catalyst**

London Catalyst is an independent grant making trust. We provide funding for charities and not for profit organisations working with people in need in the poorest areas of London. Our aims are twofold, to alleviate the effects of poverty and improve the health and well-being of Londoners, in particular people with mental and physical illness, long term health conditions and/or disabilities.

#### **London Marathon Charitable Trust**

The London Marathon Charitable Trust (LMCT) primarily provides capital funding for building or facilities projects that inspire increased participation in physical activity, sport and play.

Our present focus is engaging and supporting individuals and groups who do not currently participate in physical activity.

# **London Sport**

London Sport aims to make London the most physically active sporting city in the world and get 1,000,000 Londoners more active by 2020. They provide funding to deliver projects targeting inactive communities alongside insight services and specialist advice around technology, physical activity & health, workforce and inclusion. They have a relationship management team that aims to build local links and promote collaboration.

# Makerble / Impact Tracker

Makerble is a friendly tool designed for organisations that want to demonstrate their impact without breaking the bank. Our website and mobile app enable charities and social enterprises to collect stories and survey answers that evidence the impact you are making. Charities using the platform have halved the time they had to spend on data collection and have seen a doubling in productivity of their volunteers.

#### **Media Trust**

Media Trust is the UK's leading communications charity. They help other charities and communities to raise awareness of their causes by connecting them directly with the media industry and offering them training, film production and distribution services.

#### **One Westminster**

One Westminster aims to transform people's lives through volunteering and voluntary sector support. It provides a single organisation that can deliver for Westminster all the core functions of a Volunteer Centre and a Council for Voluntary Service.

# Royal Borough of Kensington and Chelsea Community Engagement Team

City Living, Local Life - enables local people, other community members and Councillors to identify local issues that matter and find practical ways to make their area a better place to live. Each ward that takes part in City Living, Local Life has a budget of up to £20,000 (£14,000 for the wards with two local Councillors) which acts as a source of help to get projects started, to contribute towards small one-off events or to act as match-funding from other sources. Each area of Kensington and Chelsea is unique, and has different priorities of projects supported.

Corporate Services Small Grants Fund - is a pot of £30,000 which is available in two funding rounds worth £15,000. This is a fund for voluntary and community organisations working within the Royal Borough of Kensington and Chelsea which have charitable objectives. Organisations must meet the criteria and have at least one of the following priorities: information and advice, community engagement and infrastructure and capacity building. Previous grants have been awarded for the provision of some costs for community events, essential computer equipment, training for volunteers and small scale improvements to facilities. The next round opens in October 2017.

### Sobus

Sobus has been established through the merger of the Community and Voluntary Sector Association Hammersmith & Fulham (CaVSA H&F) and the Fulham Community Partnership Trust (FCPT). It is a community development agency which also continues to be the infrastructure support body for VCO's across Hammersmith & Fulham, as well as supporting social enterprises, business start-ups, residents and statutory agencies. Sobus also operates a premises hub in Dawes Road Fulham offering meeting rooms, hot desks and a range of office facilities.

# **Space Hive**

Spacehive is a funding platform for projects that make local places better. It works by providing tools that help people develop their ideas, get noticed by crowds of people, companies, councils, the media, in order to attract funding to make great projects happen. Since launching in 2012, Spacehive has helped fund more than 300 public projects across the UK worth over £6.5m - from public wi-fi in Mansfield and an urban farm in London to a motorway flyover re-imagined as a "sky park" in Liverpool, and a giant waterslide on Bristol's high street. ### **Technology Trust**

#### **Tesco Bags of Help with Groundwork London**

Bags of Help is Tesco's exciting local community grant scheme where the money raised from the 5p bag charge is being used to fund thousands of local projects in communities right across the UK. Projects that bring benefit to their community will get the green light — these range from improving community buildings and outdoor spaces to buying new equipment, training coaches or volunteers and hosting community events. Administration of the local funding is being managed by the community charity with a green heart, *Groundwork*, which specialises in transforming communities and the local environment for the better.

#### **Trust For London**

Trust For London exists to reduce poverty and inequality in London. They do this by funding the voluntary and community sector and others, as well as by using their own expertise and knowledge to support work that tackles poverty and its root causes.

# **Volunteer Centre Kensington & Chelsea**

They promote volunteering as a force for change and social good. Their mission is to build the capacity of local people and organisations by empowering K&C community to realise their potential through volunteering. They create, develop and promote opportunities while linking, connecting and integrating people with their community.

# West London Clinical Commissioning Group / Tri-Borough Public Health

Following structural changes to the health sector in April 2013, these two local agencies will be available to explain how key developments over the last two year have supported plans for future engagement with the public, commissioning of services, and how voluntary organisations can engage with these West London Clinical Commissioning Group and Tri Borough Public Health.

# **Westminster Amalgamated Charity**

Westminster Amalgamated Charity was formed in 1961 as a result of the amalgamation of seven Westminster charities. The aim of the Charity today is to continue the activity common to all the predecessor charities, namely the relief of need in Westminster by way of Grants, for individuals and organisations.

#### **Westway Development Trust**

We were formed out of RBKC protest in 1971, when the A40 Westway Flyover was built leaving 23 acres of derelict land. We manage and regenerate this land on behalf of the local community. We offer education and training programmes and run two popular sports and fitness facilities, as well as health and fitness services. We promote arts and culture, host entertainment and events, and provide space and development opportunities to individuals, businesses, enterprise, artists and charities. In all that we do, our focus is on creating opportunity and access for those most in need.

#### **Young Hammersmith & Fulham Foundation**

The Foundation's aim is to bring more financial resources in to H&F for young people, ensure greater communications across the youth providers and be a voice for this part of the voluntary sector. The Foundation will focus on providing services to young people and is creating a holistic approach, making sure that young people gain access to services to do with: housing; employment; crime and safety; health and wellbeing; training and education and, positive activities.

### **Your Credit Union**
