- Names and contact details (phone numbers and email addresses)
- Addresses

- Photographs or video recordings
- Service use history
- Correspondence
- Information about support requirements
- Records of meetings and decisions
- Information about income and financial needs for funding or personal budget support
- Website user information (including user journeys and cookie tracking)
- Information relating to compliments or complaints and other feedback
- Incident and accident forms

We also collect or use the following special category information to **provide services and goods, including delivery and third-party referrals.** This information is subject to additional protection due to its sensitive nature:

- Racial or ethnic origin
- Age
- Gender
- Disability
- Language

We collect or use the following personal information for **service updates or marketing purposes**:

- Names and contact details (phone numbers and email addresses)
- Addresses
- Marketing preferences

- Recorded images, such as photos or videos
- IP addresses
- Website and app user journey information
- Records of consent, where appropriate

We collect or use the following personal information to **comply with legal requirements**:

- Name
- Contact information
- Identification documents
- Any other personal information required to comply with legal obligations
- Incidents and accidents

We collect or use the following personal information for **recruitment purposes**:

- Contact details (e.g. name, address, telephone number or personal email address)
- Date of birth
- National Insurance number

- Education history (e.g. qualifications)

Lawful bases and data protection rights
