2	Update on Transformation project and K&C Community Enterprises – Jenny Greenfields, KCSC & Kalwant Sahota, WL CCG	
	Presentation: Transformation project and K&C Community Enterprises.	
	Kalwant Sahota (KS) and Jenny Greenfields (JG) provided an update on Third Sector Transformation, see slides above.	
	KS discussed the objectives and scope of the transformation programme and progress to date. Funding was provided by West London Clinical Commissioning Group (WLCCG) to KCSC, in its role as an umbrella group to support the third sector. KCSC represent all organisations at key strategy meetings. They will give smaller groups a voice in WLCCG and now North West London CCG. Terms are currently still changing. Learnings from Grenfell have fed through to ensure representation.	
	JG provided background to the re-launch of KCSC's Community Interest Company (CIC). The CIC has been set up as a 'vehicle' for delivering larger contracts. A 'trading name' (Community Health West London) has been agreed and a website providing a referral pathway and general information is in development. JG described the CIC's governance structure. It has a democratic structure including a majority of representatives from local voluntary and community organisations on its Board and Advisory Council.

Palliative Care update – Lena Coupland, NWL CCG
Presentation: Palliative Care.
Lena Coupland (LC) gave an update on Local Palliative Care services providing background on the work to date and talking through engagement and next steps for services, see slides above. Carrie Hirst (CH) facilitated small groups discussion about messaging around the subject.
The session started with a definition of Palliative Care – the provision of patient services for respite, medication management or dying in a home, hospital or hospice.
LC discussed the review of palliative care services and the recommendations of a review of services carried out by West London, Hammersmith & Fulham, Brent and Westminster CCGs.
Workshops were carried out to provide feedback:
 Care works best when patient is in the pathway. Care planning should happen early and should be transparent. Patients voice can be lost in early stages, process should allow families (with patient's permission) to hear information in a timely manner not in a crisis. Not everyone knows what is meant by Palliative Care services. Not everyone knows where to go or what services are on offer.
The CCGs have received feedback from current services users, families and carers as well as other local stakeholders. After listening to their feedback potential solutions have been developed to address some of the challenges. They now want to test these ideas.
 February - There are plans for focus groups and local events. These are intended to raise awareness about local services; an opportunity to feedback on the four potential solutions as well as suggesting any additional scenarios the CCGs should consider. March/April - Engagement outcomes will be presented to the CCGs Governing Bodies followed by Mayoral Purdah. May - Any significant service changes will result in further engagement or consultations the more formal process including scrutiny committees.
Ideas on how to engage are being sought: The services available are not currently being accessed by everyone who needs them. This includes access for family, carers and friends.
The team are looking for feedback on:
 Best way to get the message out to people. Understanding the best way for people to understand palliative care. How the team work with you to work with your community? What do you need from the team to help with those messages?
How do you introduce the topic?

	The forum members were encouraged to get involved in producing ideas on messaging about Palliative Care. CH asked groups of two or three to discuss ideas.	
	Terminology and understanding in the community was discussed.

	Death cafes encouraging conversations about death and dying.	
	'Health at the end of life' was suggested. To know a team of specialists are there for	
	you at this time. This is also important for family and friends. 'End of life care' a term that is simple to understand.	
	A question about place of death decisions was raised. This decision is made by the individual and their GP.	
	The palliative care team make sure what the individual wants is in place for example	
	pain management. This is indicated in the care plan which is created once the place of	
	death decision is made.	
	The care plan records the preferred place of death and the preferred place of care.

4	Grenfell Tower wrapping – Lisa James & Sarah Hopping, Ministry of Housing, Community and Local Government	
	Lisa James (LJ) and Sarah Hopping (SH) from the Ministry of Housing, Community and Local Government (Ministry of Housing) provided an update on the Grenfell Tower	
	wrapping.	
	They explained that the Ministry of Housing took ownership of Grenfell Tower and its	
	surroundings to enable survivors and bereaved to have some say into the future of the Tower. The team consists of; day management of the site itself, Grenfell Memorial	
	Commission, the Advisory Panel and soil and environmental testing.	
	The Grenfell Tower Memorial Commission are holding two drop-in events to let residents	
	in North Kensington know about the commission and how to get involved.	
	Grenfell Tower Memorial Commission – event flyer	
	Dates: Monday 12 February, 4pm – 7pm, Kensington and Chelsea College, W10 5QQ Wednesday 12 February, 4pm – 7pm, Kensington and Chelsea College, W10 5QQ	
	SH and JL informed the Forum that they are looking to form relationships with existing	
	organisations in order to pass on updates to as many people in North Kensington as	
	possible. They are hoping to access existing networks and are happy to attend events	
	where appropriate. They asked for views on the best way to do this. Please <u>contact them</u> with any suggestions.	
	SH provided an update on the next stage of the maintenance of the wrapping around	
	Grenfell Tower. SH explained that the white wrapping and banner in place around the	
	tower needs to be replaced every two years. The scaffolding and blue wrapping around	
	the tower will remain in place while the white wrapping is replaced.	
1	Phase one of the replacement will begin over half term from 10 February starting with	
	the side facing Kensington Aldridge Academy. The panel were provided with a flyer	

providing an <u>update on the Grenfell Tower wrapping.</u>	
 JL discussed the environmental testing programmes. Stage one looking at Land contamination has been completed. JL explained that findings from air quality monitors that Public Health England have in place showed readings as expected in an urban area. Public Health England recommend no change in their advice for good hygiene including washing of fruit and vegetables. Stage two is about to start looking at Lead and Benzoate pyrene. A specialist tender process has started with an appointment expected in March 2020. Detailed testing and a full risk assessment are expected. Samples will be taken from sites identified following engagement with the community and include schools and cover a radius of 500m and a 1000m radius in a North West direction. 	
Key discussion points:	
 Enquiries were made about the air monitoring since the start of the fire. SH provided the following summary following the meeting: Air quality in the area surrounding Grenfell Tower has been assessed and monitored since the start of the fire on 14 June 2017. Initial risk assessments carried out in conjunction with partner agencies focussed on the smoke plume which rose upwards rapidly and was carried in a northerly direction by the wind. This meant that there was a low risk of impact on local air quality from the fire. Assessment of data from The London Air Quality Monitoring network was used to confirm the initial risk assessment that levels of particulate matter were low, and remained so over the next 10 days. PHE started additional monitoring of air quality close to Grenfell Tower on 24 June 2017. See the <u>air quality reports</u> for further information. The Community Champions initiative was introduced to SH and JL as a valuable source of communication were highlighted. Lesley Terry (LT) who manages the programme offered to put the Ministry of Housing team in touch with two branches. Enquiries were made about the timeline for decisions on what happens to the tower were made. No timeline is in place. A decision by the secretary of state will establish what happens to the tower. This will be based on 	LT
 technical advice, advice on psychological and social effects and impact on any active reviews in place. In the meanwhile, maintenance and safety has to be maintained. The influence of the fire on social housing decisions was raised. The Ministry 	
of Housing carried out a review to look at residents and social housing which did impact on policy at national level. More information about the report can be obtained from the Ministry of Housing.	
 The Ministry of Housing currently run drop in events at The Curve every Wednesdays between 10am and 2pm. Topics covered are site management, environmental testing and the Memorial Commission. A broader range of questions can be asked and information on how to find the answer can be provided.

	(MECC) training which is also taking place in RBKC. MECC is an approach to behavioral	
	change using day to day interactions that organisations and individuals have with each	
	other to support positive changes in physical and mental health and wellbeing. This is	
	carried out through recognising opportunities, skillful conversations and signposting.	
	• Aimed at those who work with members of the public it is free to sign up to. See	
	available sessions here. Training sessions take three hours and are delivered near	
	Latimer Road tube station or at the offices of an organisation wishing to train	
	more than six staff.
