4 Vaccine Rollout Updates – Jeff lake, Deputy Director, RBKC Public Health

Jeff Lake (JL) provided an update on the statistics around Covid transmission, vaccinations,, misinformation concerns and further vaccine science.

<u>Presentation</u>

Key points:

- Reduction in case rate over last few weeks, though still at significant levels
- Acute demand is dropping, mortality rates expected to follow shortly
- Addressed various forms of misinformation
- Explained how the vaccine has been developed so quickly, how they work and what mild side-effects are possible
- Discussed vaccine protection/transmission risks and need to continue following guidance

Joe Batty (JB) asked if you are still a potential carrier post-vaccine:

- JL said no vaccines are 100% effective and cannot guarantee protection, but you are less likely to be infected and less severe symptoms if you are. Still need to follow precautions to keep risks low.

Judith Blakeman (JB): Does vaccine work if you have antibodies?

- JL said vaccines work in different ways and understanding is not clear enough to say for sure about length of protection. No negative interaction by having vaccine and protection provided by vaccine is likely more enduring than antibodies.

Lisa Teitler (LT): How is the vaccine tested on under 18s?

	 Not currently offered to under 16s, trials not conducted on children and rates of transmission in younger children in particular is lower. Unclear yet which groups will be vaccinated over long term. 	
	Teresa Meekings (TM): Client experiencing side effects including rash and swelling?	
	 Speak with medical professional/GP, potential allergies, but very unusual case and not a high risk 	
5	Breakout Groups – Discussion of role of VCS in supporting vaccine rollout and building trust	
	Following the meeting a summary of the discussions in the three breakout groups was put together:	
	Discussion Summary	
	Breakout room 1 discussed:	
	 Need to improve information clarity and dissemination on issues like 2nd dose and how to act after 1st dose, particularly to combat misinformation among BAME communities. VCS groups can support reach and message promotion but need presentable information to share. Concerns about where people can ask questions to follow-up receiving vaccine. 	
	Breakout room 2 discussed:	
	 Having an easy ready document that could be produced that local charities could then add their logo on so that there is a consistent message given out by everyone. A major issue is that messages from the government are very inconsistent. 	
	Breakout room 3 discussed:	
	 Possible use of WhatsApp groups to address misinformation in real time using the same mediums as it is initially spread and in translated forms. Issues are that misinformation and myths are spread faster and more socially than facts. Highlighted importance of education for both communities and professionals. Joe recommended The Conversation website, (Link in the chat) 	
6	Digital Inclusion Project - Tim Ellis and Alice Adams, RBKC	
	Tim Ellis (TE) introduced himself and the work he has been carrying out as part of a joint partnership between the Health Service, RBKC and the Third Sector, around Digital Inclusion. The programme is aimed at understanding need, supporting access to devices, access to internet and improving motivation, confidence and skills in accessing resources.
