1	Welcome and Introduction – Joe Batty, Senior Community Development & Engagement Officer, KCSC			
	<u>Agenda</u>			
	JB welcomed everyone to the forum.			
2	Understanding the Support Needs of Small Organisations Providing Advice to Diverse Communities across London - Tessa Awe			
	<u>Presentation</u>			
	Tessa Awe (TA) explained that there is a lack of diverse organisation representation at strategic level. A report was compiled incorporating a survey of over 70 respondents including 1-1 interviews to look at the needs of organisation providing advice services.			
	The report will be made public in April 2021 and will look at trends in provision, funding and sustainability.			
	As the report is not finalised TA asked for feedback from those present to feedback into the report. TA asked if a smaller network of pan London organisations would be useful to discuss issues or topics that they would like taken forward. The general consensus was that this would be a good idea. Key discussion points following on from the presentation included:			
	 The complexity of paperwork can be very onerous on small organisations. The grant givers processes may not be flexible enough for the organisations needing assistance. Applications can be so long and often there is only one person to do this important but very time-consuming process. The thing missing for BAME organisations is capacity building support. There currently is a GLA network for funding that may not be well known and perhaps needs signposting to. Digital devices for service users is in high demand. Need to investigate and share the London wide information. 			
	TA will forward the full report when it is published.			

The Advice Conference 2021 – Update from Baljit Badesha, Nucleus

Baljit Badesha (BB) provided an update on the Advice Conference organised by ADKC, Age UK, Citizens Advice, KCSC, Nucleus and World's End Advice and held on 15 February 2021.

Three questions were asked:

What do clients need?

What is needed to get better access to advice?

Are there issues getting in touch with the Council in terms of accessing people rights.

The event run in conference was very well attended and generated with a lot of feedback.

Among the issues identified were:

- Poverty London's communities faced poverty even before Covid-19 and has increased.
- Digital Divide resulting in limited services.
- Language and literacy.
- No face to face contact had a massive impact.
- Knowing who was open and who was not. The door being closed presented a real problem.
- Issues with new client unaware of services available and how to access them.
- Unemployment especially among young people.
- Spaces not being accessible or Covid-19 safe.
- Housing in general and helping with self-isolation.
- People really wanted co-location to be explored.

Aim is to tackle three items over the next two months:

Space – looking at taking short appointments offering document drop off/collection. Drop in is unlikely for quite some time. Looking at co-locating with other services.

Webforms – push the use of forms for communication.

Collaboration – better co-ordination is need to build on existing processes now that things are opening up. An analysis of gap and services in the borough need to be examined. There needs to be a move toward community groups having a right to refer.

This will be revisited in three months and updates provided.

Next steps

Lockdown timetable will have the greatest impact on next steps.

Key discussion points following on from the presentation included:

- This was not research more a consultation to see what agencies have seen with regard to service users. To hear what others are seeing and hearing.
- People indicated in the chat if they wanted to be involved in a sub group to see how this can be piloted.

- This is an opportunity to engage with the wider sector to get seamless referral routes to get the best outcome for households. This is needed for information about clients referred and for agencies it is advantageous to work with other service providers to getting a 360 image.
 Crosslight Advice Service, Awrala - Kulan Somali Organisation, Ann – The Dalgarno Trust and Becky – The ClementJames Centre expressed and interest to join.
- Clients referred to RBKC services reported that they found it very disjointed with the need to tell their story numerous times. It feels to residents from feedback that there is no communication between departments.

4 RBKC Housing Needs Research - Karen Patten, Homeless Link

Presentation

Karen Patten (KP) provided information on the research into housing needs that has been commissioned by RBKC Council.

The research looks into diversity impacts on housing needs and well as health impacts as well.

The information being collected is around locality and demographic characteristics.

A focus group will be running on 30 June. The session will explore issues further an discuss possible solutions. Organisations would be welcome to attend.
